Acquisition and Business Services (ACQ)

- Acquisition and Business Services (ACQ) is committed to its customers and each other
- ACQ provides acquisition expertise to keep the National Airspace System safe and efficient
- A transparent and accountable acquisition system enables optimum value for the taxpayer





Acquisition & Contracting (AAQ)

- Provides expert Contracting Officers/Specialists to advise, plan, negotiate, award, execute and administer contracts and agreements.
- FAA's contracting activities are managed by personnel located at headquarters, the William J. Hughes Technical Center, the Mike Monroney Aeronautical Center, and regional service offices.



Acquisition Management System (AMS)

- In 1996, the Department of Transportation's Federal Aviation Administration (FAA) began using the Acquisition Management System (AMS) rather than the Federal Acquisition Regulation (FAR)
- The AMS provides policy and guidance on lifecycle acquisition management by the FAA
- Objectives of the AMS are to increase the quality, reduce the time, manage the risk, and minimize the cost of delivering safe and secure services to the aviation community and flying public

 - Demonstrate capabilities, ask questions, recommend changes, and provide feedback
 - Responses to market surveys are a key input for set-aside determination decisions
- Respond to Solicitations
 - Read instructions/evaluation criteria carefully, and always ask for clarifications when necessary
 - Request a debriefing if unsuccessful


